

Terms and conditions for Agreement

- This agreement will be for next 10.5 months i.e. 15.07.2025 to 30.05.2026.
- There will be enhancement in rent every year as per Government guidelines.
- The electricity & water charges will be Rs.250/- per month
- The rent and electricity charges to be paid by the 8th of every month.
- Proper First Aid Kit should be maintained in case of burns and cuts.
- In case the contractor herself/himself and the servants are suffering from any communicable disease she/he should make an alternative arrangement of canteen functioning or canteen working should not be there during that days.
- The contractor will not promote the use of any type of intoxicants which have harmful effects on the children like liquor, tabacoo and drugs in the canteen and school premises. Besides this, she/he shall not allow any outsider for all above mentioned activities.
- The canteen shall remain open between 7.00 am to 5.00 pm daily in working days and on the day and time when school requires its services.
- The rates of eatables to be sold in canteen cannot be altered of its own without the agreement between school canteen committee and contractor. The list of rate of all items shall be displayed inside and outside the canteen.
- The contractor will not serve tea and eatable etc. to the staff members in class room.
- The contractor and her employees have to behave politely and properly with the students and staff members.
- She/he should get the police verification along-with Medical fitness of herself/himself and his servants done by the concern authorities and same be submitted to the institution.
- The contractor will place proper covered dustbin around the canteen area and regular disposal of waste will be done by her/him only.



- The contractor has to make arrangement for cleaning the area around the canteen.
- The contractor will not serve/provide any type of junk food, soft drink and specially oily and spicy foods and toffees, chocolates etc. and will serve only nutritious and freshly cooked food. No stale food will be served to students and staff members.
- The contractor will maintain proper food standards in the canteen and standardized food product will be used and served to the students and staff members.
- The contractor will use only branded raw materials like milk, oil, gram, flour, spices etc. to be used for cooking.
- The contractor will not use canteen and school premises for any alternative business purpose.
- The contractor will not engage any type of child labour in the canteen for its functioning
- The contractor shall produce a letter of surety bond of two responsible persons of Chandigarh.
- The contract shall remain enforce from 15.07.2025 to 30.05.2026.
- The contract will adhere with all the safety norms as per SOPs.
- The contract may be cancelled with immediately effect if the services are not found satisfactory with Canteen Committee Members on any complaint (s).
